





Faculty

The core faculty for the course are from Indian Institute of Packaging, Thai Packaging Centre, Sri Lanka Institute of Packaging. One or two eminent experts from Asian countries may also be invited.

Training Methodology •

Lectures will be through audio visuals. The participants are expected to interact with the faculty and among themselves to make the programme interesting and meaningful.

Selection of Participants -

Each APF member country will select the candidates from their respective country based on qualification and experience and forward a list of 3 candidates in the order of priority to Secretary General, APF. Depending upon the response received from each country, the Secretary General will finalise the selected candidates. The last date for sending nominations is 22nd October, 2016.

Eligibility for Participation

For effective utilisation of the course, it is desirable that the participants should have adequate technical background and minimum two years experience in the field of packaging to understand course proceedings and interact effectively with the faculty and fellow participants. The participants should be graduates in science / engineering / technology. The participants could be personnel engaged in production / process, quality control, purchase, marketing activities, product-package R&D activities as well as from packaging Institutes / associations, suppliers / users of packaging materials.

And More....

Number of Participants

The course will be restricted to 15 participants.

Language Proficiency

Since the programme will be conducted in English, the participants are expected to be proficient in English language.

Fee

Each APF member country will be allowed to nominate maximum 2 members as VIP candidates. For all VIP nominees, APF will bear the registration fees, twin sharing accommodation and working lunch. But the travel arrangements are to be made by individual candidates.

However, the member countries of APF can nominate more than 2 candidates also. In such cases, the candidates have to pay registration fee of USD 100. In addition, the candidates are also required to make their travel

arrangements and accommodation at Colombo, Sri Lanka. APF will arrange for Working Lunch for participants during the programme.

In addition, the participants will be responsible for roundtrip international airfare for overseas participants, visa fee (if applicable), any meals (that are not provided by the training organisation), travelling expenses to and from the airport and training venue, and other local travelling expenses. APF will not be responsible for paying any per diem allowances or any other expense incurred by participants whatsoever.

Certificate

The APF will issue certificates to the participants on successful completion of the programme.



Eligibility

To ensure that entries represent the highest quality of packaging. AsiaStar entries must be a winner at a national packaging-related award in their country in the period of 2014, 2015 & 2016. No package which has been entered for any previous AsiaStar competition will be reconsidered. All entries should be sent through Executive Member of APF member countries For intellectual property reasons, each entry must NOT carry any commercial trademark on the package, unless it is accompanied by a letter of authorization from the brand or trademark owner.

Award Categories

There are four (4) award categories:


- 1) Consumer Package the package directed toward a consumer or household.
- 2) Transportation Package the package form used to ship, store, and handle the product or inner packages.
- 3) Eco-Package (Environmentally Sustainable Package) the package designed with special consideration for the
- environmental impacts of the package and product during its whole lifecycle.
- Student category this aims to encourage students to explore innovative ideas, packaging design, graphics and product.

In addition, the APF Presidential Award will be presented to the entry scoring maximum marks, weighted by the President's own personal criteria.

The Judging Process

Based on merit alone, AsiaStar 2016 will be judged in a secret conclave by National representatives. All packages are judged strictly on a weightedpoints basis, in which each APF member country has one vote. For AsiaStar 2016, the judging will be held in December 2016 at Mumbai, India.



Packaging export increased by 24% Packaging industry generated \$280 million surplus in 6 months

Export and import figures of the Turkish Packaging Industry for the first 6 months of 2016 have been announced. According to Turkish Packaging Manufacturers Association (ASD) report, the packaging export increased by 24% in volume, and 9% in value in comparison to the same period last year. Packaging import, on the other hand, decreased by 3% in volume but increased 5% in value in comparison to the same period.

Turkish packaging industry completed the first half of the year with surplus. One of the rarest industries which do not cause any foreign trade deficit, the packaging industry generated foreign trade surplus in the amount of \$280.2 in the first 6 months of the year.

According to the report prepared by Turkish Packaging Manufacturers Association (ASD), the packaging export, which was 790 thousand 680 tons in the first 6 months of 2015 increased to 984 thousand 134 tons in the first 6 months of this year. The volume of the export increased by 24%, from \$1.81 billion to \$1.97 billion. The import, which was 924 thousand 538 tons in the first 6 months of 2015, dropped to 897 thousand 935 tons this year. It was \$1.61 billion in the first 6 months of 2015 and increased to \$1.69 billion; its value increased by 5% whereas its volume decreased by 3%.

In terms of the types of packaging, plastic packaging has the first place with a 67% share and paper/cardboard packaging has the second place with a 23% share. The top 10 countries where the packaging industry exported most in the first 6 months of 2016 were Germany, UK, France, Iraq, Italy, Israel, Iran, Netherlands, Bulgaria and the USA.

An examination of the types of packaging imported reveals that the share of plastic packaging was 54%, and paper/cardboard packaging was 34%. In the first 6 months of 2016, the top 10 countries where Turkey imported packaging most in terms of value were Germany, China, Italy, USA, Korea, France, UK, Finland, Spain and Belgium.

Turkish Packaging Manufacturers continue to enter to new markets despite the ambiguities in the global market, and perform value added production. With its high competitive power and great potential, the packaging industry exports to more than 180 countries in the EU, Middle East, North Africa, Caucasus and the Balkans. Rapidly becoming the packaging center of Eurasia, Turkish Packaging Industry preserves its objective to achieve a \$30 billion market share and reach a \$10 billion export volume by 2023.
